# **ESTATES TEAM UPDATE** IVY REMOVAL





Ivy is a woody stemmed, selfclinging climber that can grow quickly to cover fences, walls, and buildings. Selfclinging climbers, English ivy (Hedera helix sp.) supports itself by aerial roots and where these penetrate cracks or joints, they may cause structural damage.

Ivy growing on buildings can be a cause for concern owing to its rapid pace of growth and worries about potential damage to the support structure. Its dense cover can hide defects in the fabric of the building and hinder maintenance work. Ivy may also provide access for intruders and harbour pests such as mice. Therefore, our Estates Team have been removing any ivy from WHA stock.

# WINDOWS

# ELECTRICAL SAFETY IN YOUR HOME

Electrical Installations in Tenanted properties are **tested every 5 years** to help keep you safe from the risk of Fire in your home. We employ Contractors to carry out the visits to test the Electrical circuits including sockets, wiring, cooker points and the main consumer unit to check they are safe to use. The Contractor is also carrying out **Electrical checks in common close areas** to identify any work which is required and minimise any risks of Electrical faults in the common areas.

The Contractor will contact you with an appointment to carry out these essential checks. Should appointments not be kept or access to your home not be given over a period of time, we will instruct the Contractor to force access to the property to carry out the checks. We will also pass the costs of forcing access onto you as a rechargeable appointment should you not allow access for the prearranged visit.

Please ensure you respond to all appointments, letters, e-mails and phone calls to arrange these essential visits which can be changed to suit your own circumstances.

The Team can be contacted on Tel: **0141 887 8613** to discuss your appointment time once received and make changes if needed. We can also arrange evening or weekend visits if needed to ensure the Contractor can carry out the visits. Please do not ignore any requests to arrange these essential checks.

# Scottish Child Payment increases to £25 per week

This becomes available for children, up to the age of 16, on 14 November 2022. If you have a child aged 6 to 15 you can apply from this date. The payments do not affect any other benefits you are receiving.

Until then the Scottish Government will pay eligible families the Scottish Child Payment Bridging Payments (information on December's Bridging Payment for children aged 6 and over and eligible for the free school meals due to household income - to be announced by Renfrewshire Council.

#### Who can get it?

You can get it for each child under 6 years old (under 16 years old from 14/11/2022) if you are receiving one of the benefits below:

Universal Credit, or waiting for your first payment of Universal Credit Income Support Income-based Jobseeker's Allowance Income-related Employment and Support Allowance Pension Credit Housing Benefit Child Tax Credit Working Tax Credit

## How to apply

You can apply on Social Security Scotland website or freephone helpline on 0800 182 2222 or ask for an application form to be sent to you that you can fill in and return. Please speak to our Benefits Advisor Kamila who can assist you with an application.

# WELFARE SUPPORT

The second Cost of Living Payment of  $\pounds$ 324 to be paid between 8 and 30 November.

You could get up to 3 different types of payment depending on your circumstances on a particular date or during a particular period:

- a **Cost of Living Payment** (£326 paid between 14 July to 7 September 2022 for most people and £324 that will be paid between 8 and 30 November 2022 for most eligible people, if you get a qualifying low income benefit or tax credits
- a **Disability Cost of Living Payment** (£150), if you get a qualifying disability benefit
- a **Pensioner Cost of Living Payment** (£300), if you're entitled to a Winter Fuel Payment for winter 2022 to 2023

These payments are not taxable and will not affect the benefits or tax credits you get.

# WARM HOME DISCOUNT

You could get £150 off your electricity bill for winter 2022 to 2023 under the Warm Home Discount Scheme.

#### To get it you need to either:

- get the Guarantee Credit element of Pension Credit (core group)
- be on a low income and meet your energy supplier's criteria (broader group)

# WINTER FUEL PAYMENT

You could get between £100 and £300 to help pay your energy bills. This is tax free. To get the payment, you need to be born on or before 25 September 1956. If you're entitled to a Winter Fuel Payment for winter 2022 to 2023, you'll get an extra £300 in November as a part of Cost of Living Support. The payment will be paid automatically.

You can apply online or by phoning your energy supplier (most people in core group should get a payment automatically). Speak to our Benefits Advisor or Tenancy Support Assistant if you require further assistance. This money is not paid to you - it's a one-off discount on your electricity bill (or gas bill potentially if the electricity supplied by the same supplier), between November 2022 and March 2023. Contact your supplier to find out.



# WELFARE SUPPORT

Child Winter Heating Assistance (£214.10/ per each eligible child/young person) is a payment to help disabled children, young people and their families with heating costs in winter. The payment will be paid automatically to a bank account from the end of November.

Children and young people in Scotland can get the assistance if they're under 19 years old and get one of the following 'qualifying benefits':

- the highest rate of the care component of Child Disability Payment
- the highest rate of the care component of Disability Living Allowance for children
- the enhanced daily living component of Personal Independence Payment
- the enhanced rate of the daily living component of Adult Disability Payment

They must be getting this on at least one day in the third full week of September. This includes if a qualifying benefit is backdated to this period.

#### SELF-ISOLATION SUPPORT (COVID GRANT - £250) STILL AVAILABLE TO LOW PAID WORKERS NEEDING TO SELF-ISOLATE

A self-isolation grant is available for those in low paid employment or selfemployment who are in receipt of low-income benefits and will lose income as a result of having to self-isolate to prevent the spread of coronavirus (COVID-19). The grant is also available to people who have responsibility for a child or are a carer for someone who has to self-isolate.

How to apply for the grant You can apply online for a selfisolation support grant on the Scottish Government website. You can do this any time within 28 days from the date you were advised to stay at home following a positive PCR test result. You can only apply for the grant once in any isolation period (up to 3 times from 1 May 2022). # UPDATE ON DEVELOPMENTS

Williamsburgh are delighted to take the handover of the first three blocks at **Albert Road, Renfrew** development.

The development of **42 new family homes**, for affordable rent, at Albert Road, Renfrew is being built by McTaggart Construction with an anticipated completion date of February 2023. The new homes are a mixture of terrace and semi-detached properties, will all have gardens and will be a mix of 3, 4 and 5 person properties along with two, specially designed, 4 person wheelchair bungalows.

The project costing a total of £7.3 million is being made possible by working in partnership with Renfrewshire Council and a grant of £3.317 million from The Scottish Government's Affordable Housing Supply Programme.

# BARSHAW PARK COMMUNITY GARDEN

Friends of Barshaw Park formed in 2014 and after a couple of years they attracted a lot of members. Their mission is to ensure the park is maintained and improved, It is also a place of education and leisure for every member of the Community.

Several local groups went to help in the garden, and came up with the idea that a Community Garden is what was required to better serve these Community groups by having a space designed to give groups and individuals their own small areas to take care of.

At the beginning of 2022, Friends of Barshaw entered a competition ran by the Royal Horticultural Society. They would fund the design and build of a Community Garden in each of the 4 United Kingdom countries. After a few weeks they learned they had made the last 6 for the Scottish garden. With several visits from the RHS, JJ Chalmers and a BBC Film Crew they were told that they had won!



Not only would the build of the garden be funded, but professional garden designers would design the garden to meet requirements.

Six months on, the garden is almost complete. The site has been levelled, raised beds built, and have a polytunnel and large shed. A rainwater harvesting system is being installed, and they will have a composting toilet too.

The garden design provides a large space for events and meetings, and will be ideal for activities such as exercise classes and as an outdoor classroom. There will be lots of seating areas throughout the garden, where gardeners and visitors can relax. Friends of Barshaw are very grateful to all of their volunteers, community groups, local businesses, and of course the RHS for making this all possible.

- Denial of service attack.


